






PERFORMANCE BY BUSINESS SECTOR



Revenue continued to increase in all markets, especially in the US (+48.4%) and APAC (+55.5%). Japan market saw rapid recovery with the JPY-based revenue growth of 18%.

GLOBAL IT SERVICES: 13 LARGE DEALS OF \$5MN+





Made-by-FPT products recorded **VND 406** billion in revenue, up by 51.6% YoY.


Domestic IT Services reached VND 2,630 billion (+9% YoY) in revenue and VND 263 billion in PBT (+7% YoY).



TELECOM SERVICES: EXPANDED PROFIT MARGIN

Telecom services revenue recorded double-digit growth **(+15%), reached VND 6,727 billion**. Profit margin expanded from 18.3% to 19.2% thanks to profit growth from PayTV segment.
